WHEREAS

SWISSGAS has available transportation capacity and is willing to perform the transportation service for the Shipper from the Delivery Point to the Re-Delivery Point, subject to the provisions set out here below.

The Shipper has available a certain quantity of Natural Gas at the Delivery Point and wishes to book the transportation capacity to the Re-Delivery Point from SWISSGAS.

NOW, THEREFORE THE PARTIES AGREE AS FOLLOWS

1. GENERAL

This Frame Transport Agreement lays down the terms and conditions which allow the Shipper to subscribe to Transportation Services. This Frame Transport Agreement needs to be signed prior to the start of any Transport Services.

2. GENERAL TERMS AND CONDITIONS

The current General Terms and Conditions for Transit Gas Transportation ("the General Terms and Conditions") form an integral part of this Agreement. This Frame Transport Agreement and the PRISMA deal confirmation have precedence over the General Terms and Conditions.

This Frame Transport Agreement supersedes all prior agreements, negotiations, correspondence, undertakings and communications, oral or written, with respect to such subject matter.

3. TRANSPORT SERVICE CONFIRMATION

In addition to this Frame Transport Agreement and the General Terms and Conditions the PRISMA (European Capacity Platform) deal confirmation forms an integral part of this Frame Transport Agreement. The PRISMA deal confirmation sets out the relevant details of the Transport Service. In the event of discrepancies between this Frame Transport Agreement and the PRISMA deal confirmation the latter shall prevail.

If the deal is not concluded by PRISMA platform, SWISSGAS will send out a Transport Service Confirmation to the Shipper providing the contract capacity.

4. SPECIFICATIONS OF THE GAS

The specifications of the gas delivered at the delivery point and redelivered at the redelivery point shall comply with the quality and pressure specifications set out in General Terms and Conditions.
